

Double or Triple your Gift!

You can double or even triple – your gift to Lutheran Family Services of Colorado, if your employer offers a program for matching employees’ charitable contributions. Corporations that provide a Matching Gift program establish their own guidelines with respect to employee eligibility, qualifying recipient organizations (such as Lutheran Family Services of Colorado) and the minimum and maximum contributions that can be matched. Generally, a corporation will match dollar for dollar, but some match at a higher rate.
